4. CEO REPORT- VACCINE PASSPORTS AND NFPL VACCINE POLICY IMPLEMENTATION

A. Subnaik Kilgour

- The provincial government released the regulations for vaccine certification/vaccine passports, which will come into effect on September 22, 2021
- Libraries were deemed essential at the onset of the pandemic and remain so, therefore, Libraries are not included on the list of businesses that require proof of vaccination for customers entering into our facilities
- On August 24th 2021, the Ontario Government amended O.Reg.364/20: Rules for Areas at Step 3 and at the Roadmap Exit step and O.Reg.577/21. The amendments include new requirements for all Ontario employers, namely binding Ontario Employers to "comply with any advice, recommendations, and instructions issued by the a medical officer of health requiring businesses and organizations to establish, implement, and ensure compliance with COVID-19 vaccination policies during "Step 3 Roadmap Exit Step."
- NF Public Library is compliant with the legislation as the "governing body" and our local MOH, Dr. Hiriji have not issued any formal instructions, recommendations, or requirements
