There are 2 positions available: One position at 10 weeks under the **Young Canada Works** grant and one position at 8 weeks under **Canada Summer Jobs**.

The Niagara Falls Public Library is looking for outgoing, friendly, and patient individuals who can establish good rapport with children and parents to take the TD Summer Reading Club on the road this summer to City parks, childcare centers and day camps, as well as in the library.

The successful candidates must be emotionally mature, responsible, and able to work with a minimum of supervision. Discretion, good judgment, and a love of literacy are also necessary. Previous experience working with children is an asset.

The candidates must be competent in the use of basic computer technology, including email, website navigation, spreadsheets and word processing.

A valid G-class license and access to a vehicle are required as much of the day involves traveling to outreach sites to present programs.

A Vulnerable Sector Check current to within 6 months is also required.

The candidate must be able to lift a bag or box of books weighing 20 lbs into and out of their vehicle.

**Eligibility:**

Young Canada Works Grant eligibility requirements:

- Be a Canadian citizen or a permanent resident, or have refugee status in Canada; Note: Non-Canadian students or graduates holding temporary work visas or awaiting permanent status are not eligible.
- Be legally entitled to work in Canada;
- Be between 15\* and 30 years of age at the start of employment (\*where permissible under provincial/territorial labour laws);
- Have completed the school year at the start of employment;
- Meet the specific eligibility criteria of the program to which you apply;
- Be registered in the YCW online candidate inventory;
- Be willing to commit to the full duration of the work assignment (minimum 30 hours a week); and not have another full-time job while employed in a YCW job.
- Have registered as a full-time\* student in the semester preceding the YCW job (\*as defined by their educational institution); and
- Intend to return to full-time studies\* in the semester immediately following the YCW summer job.

Canada Summer Jobs Grant eligibility requirements:

- Be between 15 and 30 years of age at the start of the employment;
- Be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the Immigration and Refugee Protection Act for the duration of the employment; and,
- Have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations.

***International students are not eligible participants. International students include anyone who is temporarily in Canada for studies and who is not a Canadian citizen, permanent resident, or person who has been granted refugee status in Canada.***
